




The civil engineering market





Strategy for forthcoming tenders

The Danish Infrastructure Plan 2035

- In 2021 more than 22 billion euros in total, including large investments in the road sector
- We already started tendering a lot of the projects in 2023, and will continue doing so

Public overview – allow the market to plan

- At the DRD's Suppliers' day 2022 and 2023, managers and project managers presented projects that are going to be tendered out within the next two years
- In 2023 and 2024 the DRD will tender out around 100 contracts, with a total value of around 650 1350 million Euros

Contract sizes

- Input from a market dialogue in 2022
 - There is a gap of contractors in the market, who are interested in contracts between 70-100M EUR.
 - Contracts below 70M EUR appeal to contractors who are already present in the Danish market
 - Contracts bigger than 100M EUR attract large international contractors


Contract form

- Road widening will in general be tendered as a Design, Bid, Build contract (DBB)
- New roads will often be tendered as a Design and Build contract (D&B)
- Structures can be tendered separately in smaller contracts as a Design, Bid, Build contract (DBB)

Managing risks

• With a lot of big projects tendered out in small contracts, it is more relevant now than ever that we can handle the interfaces between the contract

Road construction projects





- Most contracts will be awarded on the lowest price, but around 30-40% of the above contracts will be awarded on the most economically advantageous tender.
- Requirements for at minimum level of ability



Small projects to be tendered out in 2023 and 2024

- More than 60 small projects (< 5 M€) across Denmark
 - 51 contracts are tendered out as a Design, Bid, Build contract (DBB)
 - 9 are tendered out via the DRD's dynamic purchasing system
